TREATMENT & PREVENTION STAND STRONG PROVIDES TREATMENT THROUGH COUNSELING PRIMARY AND SECONDARY VICTIMS OF DOMESTIC VIOLENCE THROUGHOUT SAN LUIS OBISPO COUNTY. THEY PROVIDE ON-SITE COUNSELING IN TWO DIFFERENT LOCATIONS, AS WELL AS PROVIDING COUNSELING SERVICES THROUGH 11 DIFFERENT SCHOOLS. STAND STRONG PROVIDES TRAUMA INFORMED COUNSELING SERVICES TO HELP EDUCATE AND HEAL BOTH VICTIMS AND PERPETRATORS OF DOMESTIC VIOLENCE REGARDLESS OF RACE, COLOR, NATIONAL ORIGIN, SEXUAL ORIENTATION, AGE, GENDER, DISABILITY, BELIEF SYSTEMS, OR SPIRITUAL-BASED PRACTICES. STAND STRONG ALSO ADMINISTERS PREVENTION PROGRAMS THAT BRING ABOUT DECREASES IN DOMESTIC VIOLENCE RISK FACTORS AND INCREASES IN DOMESTIC VIOLENCE PROTECTIVE FACTORS BY ENGAGING MEN, BOYS AND ATHLETES IN

STAND STRONG HELPS VICTIMS OF DOMESTIC VIOLENCE ACHIEVE PERSONAL AND HOUSING SECURITY THROUGH THEIR SAFE HOUSE AND TRANSITIONAL HOUSING UNITS. THE SAFE HOUSE IS A CONFIDENTIAL SHELTER THAT PROVIDES SAFETY, SUPPORT AND REFERRALS TO VICTIMS OF DOMESTIC VIOLENCE AND THEIR DEPENDENTS. THE PROGRAM CONSISTS OF SAFE SHELTER, LEGAL ASSISTANCE, ADVOCACY AND COUNSELING SERVICES. STAND STRONG ALSO OPERATES THE ONLY OF ITS KIND TRANSITIONAL HOUSING PROGRAM IN SAN LUIS OBISPO COUNTY. THROUGH THIS PROGRAM STAND STRONG OFFERS TRANSITIONAL HOUSING AND SUPPORT SERVICES GEARED TOWARDS EMPOWERING SURVIVORS IN REACHING THEIR PERMANENT HOUSING AND ECONOMIC SELF-SUFFICIENCY GOALS. SPECIAL EMPHASIS IS PLACED ON PROVIDING SUPPORT TO INCREASE THEIR FINANCIAL LITERACY, EMPLOYMENT CAPACITY AND EDUCATIONAL CAPACITY TO HELP INCREASE

STAND STRONG PROVIDES HOLISTIC LEGAL SERVICES TO YOUTH AND ADULT VICTIMS OF CRIME STEMMING FROM DOMESTIC VIOLENCE, SEXUAL ASSAULT, DATING VIOLENCE AND STALKING. THE SERVICES INCLUDE LEGAL REPRESENTATION, LEGAL CONSULTATION, RELEVANT REFERRALS, COURT ACCOMPANIMENTS, AND ASSISTANCE WITH ACCESS TO ANCILLARY SERVICES.
